The NTA has been entrusted by the University Grants Commission (UGC) with the task of conducting UGC-NET, which is a test to determine the eligibility of Indian nationals for 'Assistant Professor' and 'Junior Research Fellowship and Assistant Professor' in Indian universities and colleges.

The National Testing Agency (NTA) will conduct UGC-NET December 2022 for 'Junior Research Fellowship' and eligibility for 'Assistant Professor' in **83 subjects** in Computer Based Test (CBT) mode.

- 2. Only one application is to be submitted by a candidate. In no circumstances, candidates will be allowed to fill more than one Application Form. Strict action will be taken, even at a later stage, against such candidates who have filled more than one Application Form.
