- Graduate examination of professional bodies recognised by the State Government or Central Government as equivalent to above.

**1.2 Category –II Technician (Diploma Holder) Apprentices:-**

- A Diploma in Engineering or Technology granted by a State Council or Board of Technical Education established by a State Government in relevant discipline.
- A Diploma in Engineering or Technology granted by a University in relevant discipline.
- A Diploma in Engineering or Technology granted by an Institution recognised by the State Government or Central Government as equivalent to above.

**2) Age:**

Not less than eighteen years and upper age limit is 28 years as on 31.1.2023. The upper age limit is relaxable by 5 years for SC/ST candidate, 3 years for OBC candidates and 10 years for Persons with Disability.

**3) Reservation:**

The provisions of Govt. directives for engagement of Apprentices in SC/ST/OBC/PWD Category will be applicable.

**4) Selection:**

Applications received online will be shortlisted based on eligibility criteria. In the event, the number of applications received is more, BCPL may modify the shortlisting criteria at its discretion to restrict the number of candidates to be called for Personal Interview. **5)Duration:**

Duration for engagement of apprentices is for a period of one year only.

  - All certificates/testimonials in respect of all qualifications (all semester/year wise Marksheets) starting from matriculation
- Only Indian Nationals are eligible to apply.
