#### 1. **Technical Assistant**– One (UR)Level-6 (Rs. 35,400-1,12,400)

EssentialQualification:1st class B.Tech/BSc/BCA inIT/CS from a recognized University.

DesirableQualification: Prior Experience of working in S&T Government/PSU/Autonomous Sector.

Age: Not exceeding 30 years.

#### 2. **Technical Assistant**–Two (UR) Level-6 (Rs. 35,400-1,12,400)

Essential Qualification: 1<sup>st</sup> class BSc/B.Tech in life sciences from a recognized University.

Desirable Qualification: Prior Experience of working in Medical Research Laboratory/Institute.

Age: Not exceeding 30 years.

#### 3. **Technician-1**–One (UR) Level-2 (Rs. 19,900-63,200)

Essential Qualification:12<sup>th</sup> or intermediate pass in Science subject with 55% marks and at least one year diploma in computer/IT from govt. recognized institution.

DesirableQualification: Prior Experience of working in S&T Government/PSU/Autonomous Sector.

Age: Not exceeding 28 years.

## 4. **Technician-1**–Two (UR) Level-2 (Rs. 19,900-63,200)

Essential Qualification: 12<sup>th</sup> or intermediate pass in Science subject with 55% marks and at least one year diploma in Medical Laboratory Technology from govt. recognized institution.

Desirable Qualification: Prior Experience of working in S&T Government/PSU/Autonomous Sector.

Age: Not exceeding 28 years.

### **How to Apply**

- Only applications along with essential documents in sealed envelope with superscript Application for the post of S.No-\_\_\_\_\_ (Name of the Post) received from speed post will be accepted in the name of Director, ICMR-Regional Medical Research Centre, Baba Raghav Das (BRD) Medical College, Gorakhpur, Uttar Pradesh- 273013. No other mode will not be considered.
- 2. Person working in ICMR projects continuously shall also be eligible for age relaxation upto 5 years provided he/she has entered into project service within prescribed age limit for the post.
- 3. No age relaxation against the Unreserved vacancies as per Govt. of India order No.36011/1/98/Estt(Res) dated 1/7/1998
- 4. Application fees- Rs.500/- in the form of Demand Draft in favor of **Director**, **ICMR-RMRC Gorakhpur payable at Gorakhpur**. SC/ST/PWDs and Women candidates are exempted from payment of application fee. ICMR employees are not exempted from the payment.
- 5. Application last date (i.e 10.03.2023) will be consider as cut of date for age criteria.
- 6. Appointment will be made on the basis of result of competitive test and interview
- 7. Pay and other allowances are admissible as per ICMR rules. Benefit of new restricted defined Contributory Pension is admissible for new entrants as per provision contained in the Ministry of Finance, Department of Economic Affairs (ECB /& PR Division) Notification No / 5/7/2003 ECB & PR dated 22/12/2003 effective from 1/1/2004.
- 8. Educational Qualification and experience should be from a recognized Board / Organization / Institute of repute. Experience will count after the date of acquiring prescribed essential qualifications.
- 9. No TA/DA will be paid to attend the written test and the candidates will have to make their own arrangement.
- 10. Separate application should be submitted for each post.

- 12. Those working in Central/State Government Department, Public Sector undertakings and Government funded Organization should be submit their applications with the prior permission of the employer and submit No Objection Certificate along with application form and essential documents.
